

Strait of Juan de Fuca Scenic Byway PHOTO SUBMISSION GUIDELINES

The Juan de Fuca Scenic Byway Association encourages community involvement in building a photo library depicting all aspects of activities and recreation, natural beauty and wildlife, and the people and lifestyle of the area for use in promotion of the Strait of Juan de Fuca Scenic Byway Highway 112.

Suggestions for submitted photos include, but are not limited to:

Natural beauty of the area ... beaches, forests, mountains, water, sunsets and sunrises, storms, etc.

Wildlife ... deer, otters, whales, fish, birds, etc.

Flora ... trees, flowers, mushrooms, etc.

Seasonal changes and beauty

Recreational opportunities ... fishing, hiking, biking, canoeing, kayaking, surfing, bird watching, wildlife watching, marine life watching, beachcombing, boating, camping, etc.

Trails, bridges, lighthouses, rivers, roads, towns, schools, etc.

Farming, logging, fishing industries, etc.

Historical and cultural aspects of community

Activities and events ... festivals, etc.

Views of and from highway 112

Submission guidelines:

- All photos must be taken in the highway 112 community (on/from the highway, OR on/from other areas accessed from highway 112)
- Number of photos submitted is unlimited
- Person submitting the photo must have clear rights to use the photo
- Each photo must include where taken (optional to include a "story" about the photo)
- Photos must be submitted in digital format (on a CD)
- Multiple photos can be submitted on one CD as long as clearly identified
- A b/w photocopy of photo(s) with title/number must be attached to submission form for identification
- No photos will be returned
- Some photos may not be used
- Submission of a photo for use gives the Juan de Fuca Scenic Byway Association (JDFSBA) the right to unlimited, non-exclusive use of the photo in promotional materials with credit to the JDFSBA
- No fees will be paid for use of photos for promotional use
